Matthew 25:1-13

THE WISE AND FOOLISH VIRGINS




The principal moment of a wedding at this date was when the groom went to fetch the bride from her father's house and took her to his own. The torches should be pictured as oilsoaked rags, flaming on the end of a stick, to usher him either into one house or into the other. (The little oil-lamps found in archaeological excavations would hardly be

suitable for such a celebration: they provide minimal light and would blow out in any gust of wind).

In a typical black-and-white Matthean parable the point is not that they all went to sleep, but that only some had brought oil with which to soak the rags. In Matthew this would be a stock of good works (like the wedding-garment in 22.12). The point is no longer alertness, as in the previous parable, but due preparation. It is not that the silly girls did not have enough oil; they simply did not have any; no wonder the rags kept going out! Without oil the rags wouldn't even light properly! The story is not an allegory, but only a single-point parable on the need to prepare for the final wedding. That wedding-feast is the joyful moment of the wedding of the Lord to his bride at the end of time, as so often in both Old and New Testaments.

Il tirare in lungo le trattative era di buon auspicio. Ma non è lo stesso per le spose di cui si parla nel Vangelo di oggi. Qui si tratta infatti del ritorno di Cristo e tutto è riassunto nelle ultime parole: "Vegliate, dunque, perché non sapete né il giorno né l'ora", cioè: "Siate pronte per l'arrivo di Cristo". Così la parabola delle vergini poteva cominciare con questa frase: "Per il regno dei cieli accadrà come per le dieci vergini che uscirono, con le loro lampade, incontro allo sposo". Agli occhi di Gesù, è saggio chi veglia, cioè chi pensa sempre, nel suo animo, al giorno del ritorno del Signore e all'ora della propria morte, chi vive ogni giorno nell'amicizia di Dio, nella grazia santificante, e chi si rialza subito se, per debolezza, cade. Allora "Vegliate", perché nessuno, all'infuori di Dio, conosce il giorno e l'ora.

Pastor's Corner

Dear Friends in Christ, the other day I read a heart-wrenching story concerning a critically ill 8-month-old baby named, Indi Gregory. Indi, who is a British citizen, suffers from a rare degenerative mitochondrial

disease and has been receiving life-support treatment on a ventilator from a British hospital. Despite Indi's parents' vocal, vehement desire to keep their baby girl alive, England's high court has ruled that it would be in the child's "best interest" to take her off life-support. In what can only be described as a remarkable turn of event, the Italian government, in its desire to save Indi's life, granted her citizenship and offered to cover the cost of all her medical treatment at the Bambino Gesu pediatric hospital in Rome.

The battle waged between Indi's parents and the British court essentially involve end -of-life issues. It concerns the kind of extraordinary care that critically ill individuals (including infants) should have. Alternatively, it involves asking what kind of steps should be taken in order to prolong life, particularly when the human body is at its natural end. The British court has effectively ruled that no action should be taken; death is deemed best for Indi achieved by taking her off life-support system. Conversely, and not surprisingly, Indi's parents want to keep their girl on life support system so that they can explore different treatments for her.

The Church offers a set of rules on how the faithful are to act, when confronted with end-of-life issues. The Catechism, for example, states that "Discontinuing medical procedures that are burdensome, dangerous, extraordinary, or disproportionate to the expected outcome can be legitimate; it is the refusal of "over-zealous" treatment. Here one does not will to cause death; one's inability to impede it is merely accepted. The decisions should be made by the patient if he is competent and able or, if not, by those legally entitled to act for the patient, whose reasonable will and legitimate interests must always be respected' (CCC 2278, my emphasis added).

What the Church is effectively saying is that a person is not always required to undertake extraordinary measures in order to keep himself/herself alive. Thus, a stage -four cancer patient could refuse painful chemotherapy treatment that might prolong her life; or, the use of a ventilator can be discontinued for a person whose breathing system is shutting down. To refuse treatment is not akin to a desire to die; rather, it is the coming to terms with one's mortality, and the acceptance of the inevitability of one's death.

Implicit in the same guidance, however, is an acknowledgment that a person (or his/her advocate) also has a right to undertake a treatment in order to prolong his/her life, even if it might be deemed burdensome, dangerous or extraordinary. This is clearly what Indi's parents want for their daughter; incredibly, with the help of a foreign children's hospital. The president of Bambino Gesu hospital in a published letter outlined "a detailed treatment plan" for the child, which includes "life sustaining treatment and palliative care to ensure Indi's survival comfort while the treatments take effect" (cf. "Indi Gregory Case", Catholic New Agency). Whether Indi will ultimately have the treatment generously offered by the Italian medical team remains to be seen. It will depend on whether the appellation court decides to uphold the first court's original ruling, or if they decide to overturn it.

Facing end-of-life issues and deciding what course of action to take is never an easy thing, especially when it involves infants and babies. Perhaps the larger issue at hand in Indi's case is whether those end-of-life decisions should be made by the court (as is the case here), or whether they ultimately belong to her parents (as should be the case). Shortly after granting Indi's citizenship, the Italian President Giorgia Meloni wrote on social media: "They say there isn't much hope for little Indi, but until the very end, I'll do what I can to defend her life, and to defend the right of her mamma and papa to do all that they can for her." In the end, isn't that what Indi's parents are doing - defending her life by exercising their right to do all they can for her? Pax Christi, 7r. 7homas

Dear Padre

November 12, 2023

I was taught that Catholic churches are built on consecrated ground. How can a church be torn down and replaced by a shopping mall if it's sacred ground?

Church buildings are blessed and considered by the Church to be sacred places. But when they're damaged and can no longer be repaired or their repair is impractical or they no longer effectively serve their purpose for the faithful of God, the bishop can remove that blessing. By doing this, the bishop opens them for nonsacred use. Subsequently, they can be torn down or sold, as long as the new purpose is not scandalous to the people of God.

In the end, what is truly sacred is not the brick and mortar or even the soil, but the purpose for which they were built. Churches are blessed and declared sacred because we perform sacred rituals within them. When those rituals are no longer being performed in that location, there is no longer a need for them to be declared sacred.

When a church is closed, it is often a sad event. Many people carry deep emotional ties to their parish churches. But a diocese cannot always maintain all of its churches. Catholic populations shift, local needs change. Money is limited, and good stewardship demands that bishops sometimes make the difficult decision to close or merge parishes. Remember what is truly important and of ultimate and sacred value-our worship and service of God. •
